RESOLUTION NO. R05-2025-452

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CROWLEY, TEXAS, CANVASSING AND DECLARING THE RESULTS OF THE MAY 3, 2025 GENERAL ELECTION FOR THE PURPOSE OF ELECTING CITY COUNCIL MEMBERS TO THE OFFICE OF THE MAYOR, COUNCIL PLACE 2 AND PLACE 3; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Crowley (the “City”) is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5, of the Texas Constitution and Chapter 9 of the Local Government Code; and

WHEREAS, on May 3, 2025, the City’s General Election was held in accordance with the Election Code for the purpose of electing members to the Office of the Mayor, City Council Place 2 and Place 3; and

WHEREAS, state law requires that the governing body of the City of Crowley canvass all elections.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CROWLEY, TEXAS:
